Category of information published

The Publication Scheme guides you to information which we currently publish, or have recently published, or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:

Academic Prospectus – information published in the Academy prospectus

Students and Curriculum – information about policies that relate to students and the Academy curriculum

Academy Policies and other information related to the Academy – information about policies that relate to the Academy in general

Race Equality Policy	Statement of policy for promoting race equality
Careers Education Policy	Statement of the programmes of careers education provided for Key Stage 4
Child Protection Policy	Statement of policy for safeguarding and promoting welfare of students at the Academy
Student Discipline	Statement of general principles on behaviour and discipline, and of measures taken by the Principal to prevent bullying

Academy session times and term dates	Details of Academy sessions and dates of Academy terms and holidays
Health and Safety Policy and risk assessment	Statement of general policy with respect to health and safety at work of employees (and others) and the organisation and arrangements for carrying out the policy
Complaints procedure	Statement of procedures for dealing with complaints
Appraisal Procedure for Staff	Statement of procedures adopted by the governing body relating to the appraisal of staff and the annual report of the Principal on the effectiveness of appraisal procedures
Staff Conduct, Discipline and Grievance	Statement of procedure for regulating conduct and discipline of Academy staff and procedures by which staff may seek redress for grievance
Curriculum circulars and statutory instruments	Any statutory instruments, departmental circulars and administrative memoranda sent by the Department of Education and Skills to the Principal or governing body to the curriculum
